




**Transfer Characteristics**




**On Resistance vs. Drain Current**



**Capacitance**




**Gate Charge**




**On-Resistance vs. Junction Temperature**




**Forward Diode Voltage vs. Temp.**




**On-Resistance vs. Gate-to-Source Voltage**







**Current Derating\***




**Power, Junction-to-Case**




